## Deer Creek District Library - Regular Board Meeting, Monday, October 2nd, 2023

Call to Order - President Annette Brehmer, called the meeting to order at 6:00 p.m.

**Roll Call, record present and absent members** – In attendance were board members Annette Brehmer, Betty Rock, Bev Potts, Linda Brown, Linda Staley, Shea Kamp and Brenna McGahan. Library Director, Meghan Meadows was also in attendance.

President's Report - None

**Secretary's Report** – The minutes for the regular September 11th, 2023 board meeting were reviewed and approved on a motion made by Bev Potts, seconded by Linda Brown, all in favor.

**Correspondence** – The library received a letter from RSA concerning their independence from the RAILS system. There will be a new fee structure with the organizational change, but the details are unknown at this time.

**Other** - Linda Brown updated the board on quarter auction details and how the library could be involved as a fundraising opportunity.
